Law Schools Aid Judicial Reform

THE Program in Judicial Administration recently inaugurated by the University of Denver law school re-emphasizes the vital role of law schools in the judicial reform movement. This is the third such program permanently established in recent years as an adjunct to a law school, the others being the Institute of Judicial Administration at New York University and the Project for Effective Justice at Columbia. In the same connection should be mentioned the support and sponsorship by Northwestern University and the University of Michigan of the American Judicature Society during the first 40 of its 50 years, and the housing and staffing of state judicial councils by the University of Washington and the University of Michigan.

Other law schools have carried on and are carrying on individual projects of major importance to judicial administration, as witness the jury project of the University of Chicago and various activities of the Southwestern Legal Center at Southern Methodist University in Dallas. State and regional judicial reform conferences have been and are being housed and co-sponsored by the University of Nebraska, University of Wisconsin, University of Oklahoma, University of Nevada, Ohio State University, the University of Colorado and others.

The University of Florida and the University of Washington made judicial administration history a few years ago by pioneering judicial train-
